**Conclusion:**

On the base of the laboratory analysis it was found out that in the chemical respect the sample complies with the requirements of Regulation of the Ministry of Health No. 304/2004 Coll. as amended, by which sorts and conditions of the use of accessorial and auxiliary matters (synthetic dye) at the production of foodstuff are stated.

Metals content and microbiological indicators comply with the requirements of In – house specifications no. 01/2007 of firm Aminostar s.r.o.. Quality parameters were not evaluated.

The conclusion of the laboratory analysis can be applied for the other products of the same sort only in case the products comply with the tested sample as for the composition and characteristics.

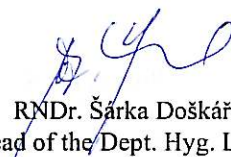
