Conclusion:

On the base of the laboratory analysis it was found out that in the chemical respect the sample complies with the requirements of Regulation of the Ministry of Health No. 304/2004 Coll. as amended, by which sorts and conditions of the use of accessory and auxiliary matters (sweeteners, synthetic dye) at the production of foodstuff are stated.
